

Budget has not contributed much for Hotel Sector



Hotel Association Nepal said that the budget of 2080/081 has not contributed significantly to solving the problems of the problematic hotel sector. Introduction of the 'luxury tax' to be levied in high end hotels will further hike price, which is deemed ill-timed for tourism sector.

The tourism decade announced by the previous government has been re-announced but 5 important months have already elapsed and no reasonable preparation is seen as of now.

Restructuring of Nepal Aviation Authority is encouraging, yet, the issue is of proper implementation and consistency of the undertakings. Hotel Association of Nepal will support the announcement of the budget for international flights from Bhairahawa and Pokhara regional international airports as this is a key issue for increasing more tourists in the country and supporting other prolific tourist areas of Nepal. The proper study the possibility of cannabis cultivation and legal branding could prepare a solid ground for health tourism. Meanwhile, HAN demands to pave ways for building of hotels in various places and overall infrastructure including road accessibility is a prerequisite for all hotels.

In order to overcome the current economic crisis, tourism sector should be accorded priority status and a collaborative approach is the need of this hour with focus to reconstruction of heritage sites, conservation of foot trails, monasteries and museums, high-altitude adventure sports tourism, Great Himalayan Trail among others. HAN has also stated that the participation of the private sector should be promoted and the investment climate coupled with proper facilitation called for the robust development in this sector.

Overall, it is not an exciting budget for tourism sector though the campaign like 'Visit Nepal: Know Nepal' is an appreciable effort. HAN has demanded a special financial policy to be introduced for such an industry that holds prospect for viable development in Nepal, which this budget has failed at large.

Tiger Tops in Chitwan National Park: A Report

English translation of the report Jim met then prince Basundhara published in Setopati Digital Newspaper on Chaitra 28, 2079.

A few days ago, Prime Minister Pushpa Kamal Dahal 'Prachanda', while talking to reporters at his house in Shivnagar, related to the Tiger Tops Hotel inside Chitwan National Park but he also expressed the opinion that it should be opened for tourism promotion.

"Opening some resorts including Tiger Tops without affecting other security will be beneficial now for tourism industry. At first, even the people in Chitwan said that they should not allow anyone to run such property. Now that's not the case," he said. "There will be a positive decision on this matter now."

In the year 2069 BS, along with Tiger Tops, Island Jungle Lodge, Temple Tigers Lodge, Safari Narayani, Chitwan Jungle Lodge, Machan Wild Camp were closed within the park by the verdict of the Supreme Court.

The government had approved the operation of these hotels based on Section 6 of the National Parks and Wildlife Protection Act 2029 BS. In this section, there is a provision that the opening of hotels and resorts within the park can be done by contract according to the purpose of the Act. The government used to extend the deadline of the hotels by adopting the same arrangement before but finally, in the year 2069 BS, the Supreme Court ordered the closure of the hotels.

Before this, the hotels inside the park which used to be popular among foreign visitors, stopped their operation for good. This has brought to the end of popular destination of wildlife tourism in Nepal.

Among the seven hotels, Tiger Tops is the oldest. This hotel was opened about 9 years before the establishment of Chitwan National Park in 1973. Initially it was opened as a simple hunting lodge. In 1964, American citizens Toddy Lee Wanna and Herv Kelly opened a company called Tiger Tops Hunting, three years before the lodge opened, in 1961, Oueen Elizabeth II of Great targeting this royal visit.

In 1971, the lodge was purchased by British citizen Jim Edwards, a pioneer of tourism. During his visit to India, safari tourism worldwide. Wildlife

Shah, brother of late kind Mahendra. In 1962, Jim came to Nepal at the invitation of prince Basundhara. He was attracted by the natural beauty here. In 1964, he established Nepal's first tourism company, Nepal Wildlife Chitwan, not only told the anecdotes Adventure Pvt. Ltd, together with American wildlife ecologist Dr. Charles (Chuck) McDougal who popularized this site with the flow of many tourists.

Jim, who started working in tourism business while staying in Nepal heard the news that the hunting lodge opened in the forest of Chitwan was on sale. He then purchased Tiger Tops Hunting Lodge together with McDougal. After Jim took over the lodge, which was opened for hunting purposes initially, turned to be the center of wildlife conservation as well. McDougal, who had already established the identity of the conservationist, took over the role of Life Resort and Gaida Wild Life conservation while Jim looked after management, which Jim did with the help of his brother John. They were also instrumental in establishing the Chitwan National Park in 1973.

In 1974, MacDougall started the world's first long-term tiger monitoring program here, which played a central role in tiger conservation in Nepal. Even now Nepal Tiger Trust is active in conservation campaign in Nepal.

Likewise, Tiger Tops also played a pivotal role in establishing the 'Ghariyal Breeding Center' in Chitwan National Park in 1978. In 1980, Jim Edwards founded the International Fund for Nature Conservation (ITNC) which worked at the grassroots level to help protect wildlife endangered by humans.

When hunting tourism started in Nepal, safari hunting tourism was also gaining popularity in Africa. Rich people used to travel to the forests of Africa to hunt and spend money in their hotels. After the opening of Tiger Tops in Chitwan, tourists going to Africa started diverting to Nepal to spend a lot of money. After starting to work on conservation, the Tiger Tops made a name for itself.

Nepal's cool climate, lush green forests and activities captivated a lot Britain accompanied by Prince Philip of tourists. Tiger Tops also operated visited to this area for hunting. Mr Ashiq Gurung, manager of Tharu Lodge in Nawalpur, says that the number of guests who used to come when Tiger Tops was in operation has stopped coming now. I could see a lot of wildlife activities then and some of them even came to the Tharu Lodge. They complain that they can't be seen like before," says Gurung, "We want to bring quality tourists rather than numbers. We wish that tourists who understand the importance of wildlife would come, but there are very few such tourists coming now.'

Ms Renu Dahal, Mayor of Bharatpur Metropolitan City, said that tourism experts have suggested that the hotels inside the park should be re-operated. The kind of hustle and bustle that used to be there when Tiger Tops was in operation is not any more now. Tourism activity has gone down and further weakened. We have received a suggestion that it should be put into operation again," she said. "We will take it forward after discussing with all the concerned parties."

After the closure of the hotels, in 2069 BS, the Council of Ministers formed a working group under the coordination of Ministry of Forests and Land Conservation to submit recommendations on appropriate


long-term measures in terms of the balance between national and international practices, prevailing laws and economic-environmental impact regarding the construction, operation and regulation of tourist structures within the park area. The task force also formed a subcommittee to study it. But as the work did not go ahead smoothly, advocate Mr Bijay Kumar Basnet filed a writ in the Supreme Court demanding that the government form a task force and stop the operation of hotels inside the While hearing the writ, the joint

bench of Justices Mr Kalyan Shrestha and Ms Sushila Karki ordered that a mechanism should be established immediately to ensure that there is no illegal adverse environmental impact. "Since the park area is a sensitive and important environmental area, the government and related parties working under Section 6 of the National Parks and Wildlife Protection Act 2029 should try not to adversely affect the forests, wildlife, their habitats and other facilities in the area. As the issue of contracting under Section 6 of the Act is a matter of discretion of the government which can be decided under the valid principles of law and justice, this court could not interfere." the order

The head of administration Mr Gurung said that the court has decided that the government has the right to allow hotels to operate without adversely affecting the environment, so the decision of the government is being awaited.
